INSTITUTIONAL MULTI-SITE LICENCE AGREEMENT EUP JOURNALS ONLINE

IMPORTANT: BY COMPLETING THE ONLINE REGISTRATION MATERIALS, AND BY ENTERING 'YES' TO ACCEPT OUR TERMS AND CONDITIONS, THE INSTITUTION NAMED IN THE ONLINE REGISTRATION MATERIALS ACKNOWLEDGES THAT IT HAS READ AND AGREES TO BE BOUND BY THE TERMS OF THIS AGREEMENT.

Edinburgh University Press of The Tun - Holyrood Road, 12 (2f) Jackson's Entry, Edinburgh, EH8 8PJ, United Kingdom ("the Publisher")

and

the Institution named in the Online Registration Materials ("the Licensee")

WHEREAS the Publisher holds the rights granted under this Licence

AND WHEREAS the Licensee desires to use the rights and the Publisher desires to grant to the Licensee the licence to use the rights for the Fee, subject to the terms and conditions of this Licence.

IT IS AGREED AS FOLLOWS: -

1.0 MULTI-SITE LICENCE DEFINITION

The Publisher hereby grants to the Licensee and its Authorised Users a non-exclusive, revocable, non-transferable Licence to access the Licensed Material, according to the terms of this Agreement, and to make the uses permitted and described below.

The Publisher defines a multi-site licence as one that applies to organizations or groups of organizations with more than two independently administered/managed locations within one city; or based in separate physical sites making a joint purchase; or in more than two cities, states or countries requiring central administration of the licence.

2.0 KEY DEFINITIONS

2.1 In this Licence, the following terms shall have the following meanings: -

Agent	A third party appointed from time to time by the Licensee to act on the Licensee's behalf, who may undertake any or all of the obligations of the Licensee under this Licence, as agreed between the Licensee and the Agent.
Authorised Users	Current members of the faculty and other staff of the Licensee (whether on a permanent, temporary, contract or visiting basis) and individuals who are currently studying at the Licensee's institution, who are permitted to access the Secure Network from within the Library Premises or offsite via a modem link to a valid IP address on the Licensee's Secure Network or who have been issued by the Licensee with a password or other authentication together with other persons who are permitted to use the Licensee's library or information service and access the Secure Network but only from computer terminals within the Library Premises.
Commercial Use	Use for the purposes of monetary reward (whether by or for the Licensee or an Authorised User) by means of sale, resale, loan, transfer, hire or other form of

exploitation of the Licensed Materials. For the avoidance of doubt, neither recovery of direct costs by the Licensee from Authorised Users, nor use by the Licensee or by an Authorised User of the Licensed Materials in the course of research funded by a commercial organisation, is deemed to be Commercial Use.

Course Packs	A collection or compilation of printed materials (e.g. book chapters, journal articles) assembled by members of staff of the Licensee for use by students in a class for the purposes of instruction.
Electronic Reserve	Electronic copies of materials (e.g. book chapters, journal articles) made and stored on the Secure Network by the Licensee for use by students in connection with specific courses of instruction offered by the Licensee to its students.
Learning Object	A self-contained unit of learning, education or training comprising information content, learning activities and metadata designed to explain a stand-alone learning objective.
Library Premises	The physical premises of the library or libraries operated by the Licensee.
Publisher's Representative	A third party appointed from time to time by the Publisher to act on the Publisher's behalf, who may execute this Licence on behalf of the Publisher and undertake any or all of the Publisher's obligations under this Licence, as agreed between the Publisher and the Publisher's Representative.
Licensed Materials	The online version of each of the Publisher's journals for which the Licensee holds a current institutional subscription for online access or which includes online access.
Online Registration Materials	The registration materials required to be submitted by the Licensee before the Licensee can access the Licensed Materials.
Secure Network	A network (whether a standalone network or a virtual network within the Internet) which is only accessible to Authorised Users approved by the Licensee whose identity is authenticated at the time of log-in and periodically thereafter consistent with current best practice, and whose conduct is subject to regulation by the Licensee.
Server	The server, either the Publisher's server or a third party server designated by the Publisher, on which the Licensed Materials are mounted and may be accessed.
Subscription Period	That period commencing on the date on which the Online Registration Materials are completed and in relation to Licensed Materials shall continue (subject to provisions for earlier termination contained below) for so long as the Licensee has a current institutional subscription for that Licensed Material for online access or which includes online access.
Text Mining	a machine process by which information may be derived by identifying patterns and trends within natural language through text categorisation, statistical pattern recognition, concept or sentiment extraction, and the association of natural language with indexing terms.
Virtual Learning Environment	A software system designed to manage and support teaching and learning in education, including systems variously referred to as Course Management Systems, Learning Management Systems, Learning Support Systems, Managed Learning Environments, and similar names.

3.0 AGREEMENT

- 3.1 This Licence shall commence at the beginning of the Subscription Period, for each of the Licensed Materials as named in the Online Registration Materials; and shall automatically terminate at the end of the Subscription Period, unless the parties have previously agreed to renew it.
- 3.2 On termination of this Licence, the Publisher shall provide continuing access for Authorised Users to that part of the Licensed Materials which was published and paid for within the Subscription Period, either from the Server or from the archive described in 8.4 or by supplying electronic files or printed copies to the Licensee subject to payment of such fees as the parties may agree except where such termination is due to a breach of the Licence by the Licensee which the Licensee has failed to remedy as provided in 11.1.2 of this Licence, in which case such continuing access shall be provided in respect of Licensed Materials published up to the date of such breach.

4. USAGE RIGHTS

- 4.1 The Licensee, subject to clause 7 below, may:
- 4.1.1 make such temporary local electronic copies by means of caching of all or part of the Licensed Materials as are necessary solely to ensure efficient use by Authorised Users and not to make available to Authorised Users duplicate copies of the Licensed Material.
 - 4.1.2 allow Authorised Users to have access to the Licensed Materials from the Server via the Secure Network.
 - 4.1.3 provide Authorised Users with integrated access and an integrated author, article title, abstract and keyword index to the Licensed Material and all other similar material licensed from other publishers via the Secure Network.
 - 4.1.4 provide single printed or electronic copies of single articles at the request of individual Authorised Users.
 - 4.1.5 display, download or print the Licensed Materials for the purpose of internal marketing or testing or for training Authorised Users or groups of Authorised Users.
- 4.2 Authorised Users may, in accordance with the copyright laws of Scotland and subject to clause 6 below:
- 4.2.1 search, view, retrieve and display the Licensed Materials.
 - 4.2.2 print a copy or download and save individual articles or items of the Licensed Materials for personal use.
 - 4.2.3 use individual parts of the Licensed Materials within Learning Objects for the Licensee's teaching, learning or training purposes.
 - 4.2.4 use Text Mining technologies to derive information from the Licensed Materials.
 - 4.2.5 distribute a copy of individual articles or items of the Licensed Materials in print or electronic form to other Authorised Users or to other individual scholars collaborating with Authorised Users but only for the purposes of research and private study; for the avoidance of doubt, this sub-clause shall include the distribution of a copy for teaching purposes to each individual student Authorised User in a class at the Licensee's institution.
 - 4.2.6 download a copy of individual articles or items of the Licensed Materials and share the same with Authorised Users or other individual scholars collaborating in a specific research project with such Authorised Users provided that it is held and accessible within a closed network that is not accessible

to any person not directly involved in such collaboration and provided that it is deleted from such network immediately upon completion of the collaboration.

4.3 Nothing in this Licence shall in any way exclude, modify or affect any of the Licensee's statutory rights under the copyright laws of Scotland

5.0 SUPPLY OF COPIES TO OTHER LIBRARIES

5.1 The Licensee may, subject to clause 7 below, supply to an Authorized User of another library within the same country as the Licensee a copy of an individual document being part of the Licensed Materials by post, fax or electronic transmission via the Internet or otherwise, for the purposes of research or private study and not for Commercial Use.

6.0 COURSE PACKS AND ELECTRONIC RESERVE

6.1 The Licensee may, subject to clause 7 below, incorporate parts of the Licensed Materials in printed Course Packs and Electronic Reserve collections and in Virtual Learning Environments for the use of Authorised Users in the course of instruction at the Licensee's institution, but not for Commercial Use. Each such item shall carry appropriate acknowledgement of the source, listing title and author of the extract, title and author of the work, and the publisher. Copies of such items shall be deleted by the Licensee when they are no longer used for such purpose. Course packs in non-electronic non-print perceptible form, such as audio or Braille, may also be offered to Authorised Users who, in the reasonable opinion of the Licensee, are visually impaired.

7.0 PROHIBITED USES

7.1 Neither the Licensee nor Authorised Users may:

7.1.1 remove or alter the authors' names or the Publisher's copyright notices or other means of identification or disclaimers as they appear in the Licensed Materials;

7.1.2 systematically make print or electronic copies of multiple extracts or make multiple copies of any part of the Licensed Materials for any purpose other than expressly permitted by this Licence;

7.1.3 prepare derivative works or download, mount or distribute any part of the Licensed Material on any electronic system or network, including without limitation the Internet and the World Wide Web, other than the Secure Network, except where expressly permitted by this Licence under clause 4.2.6;

7.1.4 reverse engineer, decompile, alter, abridge or otherwise modify the Licensed Materials or any part of them for any purpose whatsoever, except as expressly provided in this Licence.

7.2 The Publisher's explicit written permission must be obtained in order to:

7.2.1 use all or any part of the Licensed Materials for any Commercial Use;

7.2.2 systematically distribute the whole or any part of the Licensed Materials to anyone other than Authorised Users;

7.2.3 publish, distribute or make available the Licensed Materials, works based on the Licensed Materials or works which combine them with any other material, other than as permitted in this Licence;

7.2.4 alter, abridge, adapt or modify the Licensed Materials, except to the extent necessary to make them perceptible on a computer screen to Authorised Users. For the avoidance of doubt, no alteration of the words or their order is permitted.

8.0 PUBLISHER'S UNDERTAKINGS

8.1 The Publisher warrants to the Licensee that the Licensed Materials used as contemplated by this Licence do not infringe the copyright or any other proprietary or intellectual property rights of any person. The Publisher shall indemnify and hold the Licensee harmless from and against any loss, damage, costs, liability and expenses (including reasonable legal and professional fees) arising out of any legal action taken against the Licensee claiming actual or alleged infringement of such rights. This indemnity shall survive the termination of this Licence for any reason. This indemnity shall not apply if the Licensee has amended the Licensed Materials in any way not permitted by this Licence.

8.2 The Publisher shall:

8.2.1 make the Licensed Materials available to the Licensee from the Server via the Internet access to which is authenticated by Internet Protocol Address and Shibboleth. The Publisher will notify the Licensee and the Agent at least ninety (90) days in advance of any anticipated specification change applicable to the Licensed Materials. If the changes render the Licensed Materials less useful in a material respect to the Licensee, the Licensee may within thirty days of such notice treat such changes as a breach of this Licence under clause 11.1.1 and 11.4.

8.2.2 use reasonable endeavours to make available the electronic copy of each journal issue in the Licensed Materials not later than the day of publication of the printed version. In the event that for technical reasons this is not possible for any particular journal, as a matter of course, such journal shall be identified at the time of licensing, together with such reasons.

8.2.3 use reasonable endeavours to ensure that the Server has adequate capacity and bandwidth to support the usage of the Licensee at a level commensurate with the standards of availability for information services of similar scope operating via the World Wide Web, as such standards evolve from time to time over the term of this Licence.

8.2.4 use reasonable endeavours to make the Licensed Materials available to the Licensee and to Authorised Users at all times and on a twenty-four hour basis, save for routine maintenance (which shall be notified to the Licensee in advance wherever possible), and to restore access to the Licensed Materials as soon as possible in the event of an interruption or suspension of the service.

8.3 The Publisher reserves the right at any time to withdraw from the Licensed Materials any item which infringes copyright or is defamatory, obscene, unlawful or otherwise objectionable. The Publisher shall give written notice to the Licensee of such withdrawal. If the withdrawal represents more than ten per cent (10%) of the book, journal or other publication in which it appeared, the Publisher shall refund to the Licensee that part of the Fee that is in proportion to the amount of material withdrawn and the remaining un-expired portion of the Subscription Period.

8.4 The Publisher undertakes to provide or to make arrangements for a third party to provide an archive of the Licensed Materials for the purposes of long term preservation of the Licensed Materials, and to permit Authorised Users to access such archive after termination of this Licence.

8.5 Collection and analysis of data on the usage of the Licensed Materials will assist both the Publisher and the Licensee to understand the impact of this Licence. The Publisher shall provide to the Licensee or facilitate the collection and provision to the Licensee and the Publisher by the Licensee of such usage data on the number of abstracts and of articles downloaded, by journal title, on a monthly and an annual basis for the Publisher's and the Licensee's private internal use only. Such usage data shall be compiled in a manner consistent with applicable privacy and data protection laws, and the anonymity of individual users and the confidentiality of their searches shall be fully protected. In the case that the Publisher assigns its rights to another party under clause 12.3, the Licensee may at its discretion require the assignee either to keep such usage information confidential or to destroy it.

- 8.6 EXCEPT AS EXPRESSLY PROVIDED IN THIS LICENCE, THE PUBLISHER MAKES NO REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, WARRANTIES OF DESIGN, ACCURACY OF THE INFORMATION CONTAINED IN THE LICENSED MATERIALS, MERCHANTABILITY OR FITNESS OF USE FOR A PARTICULAR PURPOSE. THE LICENSED MATERIALS ARE SUPPLIED 'AS IS'.
- 8.7 EXCEPT AS PROVIDED IN CLAUSE 8.1, UNDER NO CIRCUMSTANCES SHALL THE PUBLISHER OR THE PUBLISHER'S REPRESENTATIVE BE LIABLE TO THE LICENSEE OR ANY OTHER PERSON, INCLUDING BUT NOT LIMITED TO AUTHORISED USERS, FOR ANY SPECIAL, EXEMPLARY, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY CHARACTER ARISING OUT OF THE INABILITY TO USE, OR THE USE OF, THE LICENSED MATERIALS. IRRESPECTIVE OF THE CAUSE OR FORM OF ACTION, THE PUBLISHER'S AGGREGATE LIABILITY FOR ANY CLAIMS, LOSSES, OR DAMAGES ARISING OUT OF ANY BREACH OF THIS LICENCE SHALL IN NO CIRCUMSTANCES EXCEED THE FEE PAID BY LICENSEE TO THE PUBLISHER UNDER THIS LICENCE IN RESPECT OF THE SUBSCRIPTION PERIOD DURING WHICH SUCH CLAIM, LOSS OR DAMAGE OCCURRED. THE FOREGOING LIMITATION OF LIABILITY AND EXCLUSION OF CERTAIN DAMAGES SHALL APPLY REGARDLESS OF THE SUCCESS OR EFFECTIVENESS OF OTHER REMEDIES. REGARDLESS OF THE CAUSE OR FORM OF ACTION, THE LICENSEE MAY BRING NO ACTION ARISING FROM THIS LICENCE MORE THAN TWELVE (12) MONTHS AFTER THE CAUSE OF ACTION ARISES.
- 9.0 LICENSEE'S UNDERTAKINGS
- 9.1 The Licensee shall:
- 9.1.1 use reasonable endeavours to ensure that all Authorised Users are aware of the importance of respecting the intellectual property rights in the Licensed Materials and of the terms and conditions of this Licence, and use reasonable endeavours to notify Authorised Users of the terms and conditions of this Licence and take steps to protect the Licensed Materials from unauthorised use or other breach of this Licence;
- 9.1.2 use reasonable endeavours to monitor compliance and immediately upon becoming aware of any unauthorised use or other breach, inform the Publisher and take all reasonable and appropriate steps, including disciplinary action, both to ensure that such activity ceases and to prevent any recurrence;
- 9.1.3 issue passwords or other access information only to Authorised Users and use all reasonable endeavours to ensure that Authorised Users do not divulge their passwords or other access information to any third party;
- 9.1.4 keep full and up-to-date records of all IP addresses and provide the Publisher with details of such additions, deletions or other alterations to such records as are necessary to enable the Publisher to provide Authorised Users with access to the Licensed Materials as contemplated by this Licence;
- 9.1.5 use reasonable endeavours to ensure that only Authorised Users are permitted access to the Licensed Materials.
- 9.2 THE LICENSEE AGREES TO INDEMNIFY, DEFEND AND HOLD THE PUBLISHER HARMLESS FROM AND AGAINST ANY LOSS, DAMAGE, COSTS, LIABILITY AND EXPENSES (INCLUDING REASONABLE LEGAL AND PROFESSIONAL FEES) ARISING OUT OF ANY CLAIM OR LEGAL ACTION TAKEN AGAINST THE PUBLISHER RELATED TO OR IN ANY WAY CONNECTED WITH ANY USE OF THE LICENSED MATERIALS BY THE LICENSEE OR AUTHORISED USERS OR ANY FAILURE BY THE LICENSEE TO PERFORM ITS OBLIGATIONS IN RELATION TO THIS LICENCE, PROVIDED THAT NOTHING IN THIS LICENCE SHALL MAKE THE LICENSEE LIABLE FOR BREACH OF THE TERMS OF THE LICENCE BY ANY AUTHORISED USER PROVIDED THAT THE LICENSEE DID NOT CAUSE, KNOWINGLY ASSIST OR CONDONE THE CONTINUATION OF SUCH BREACH TO CONTINUE AFTER BECOMING AWARE OF AN ACTUAL BREACH HAVING OCCURRED.

10. UNDERTAKINGS BY BOTH PARTIES

- 10.1 Each party shall use its best endeavours to safeguard the intellectual property, confidential information and proprietary rights of the other party.
- 10.2 The Publisher permits Licensees who participate in the LOCKSS system for archiving digitized publications to perpetually use the LOCKSS system to archive and restore the Licensed Materials, so long as Licensee's use is otherwise consistent with this Agreement. Publisher further acknowledges and agrees that, for the purpose of repairing damage to or loss of another LOCKSS system's copy of Licensed Materials, Licensee's LOCKSS system may make Licensed Materials available to that other LOCKSS system provided that the other LOCKSS system had previously proven to Licensee's system that it had the same Licensed Materials.

11. TERM AND TERMINATION

- 11.1 In addition to automatic termination (unless renewed) under clause 3.1, this Licence shall be terminated:
- 11.1.1 if the Publisher commits a material or persistent breach of any term of this Licence and fails to remedy the breach (if capable of remedy) within sixty (60) days of notification in writing by the Licensee;
- 11.1.2 if the Licensee commits a wilful material and persistent breach of the Publisher's copyright or other intellectual property rights or of the provisions of clause 4 in respect of usage rights or of clause 7 in respect of prohibited uses;
- 11.1.3 if either party becomes insolvent or becomes subject to receivership, liquidation or similar external administration.
- 11.2 On termination all rights and obligations of the parties automatically terminate except for obligations in respect of Licensed Materials to which access continues to be permitted as provided in clause 3.2.
- 11.3 On termination of this Licence for cause, as specified in clause 11.1.2, the Licensee shall immediately cease to distribute or make available the Licensed Materials to Authorised Users.
- 11.4 On termination of this Licence by the Licensee for cause, as specified in clause 11.1.1 above, the Publisher shall forthwith refund the proportion of the Fee that represents the paid but un-expired part of the Subscription Period.

12. GENERAL

- 12.1 This Licence constitutes the entire agreement of the parties and supersedes all prior communications, understandings and agreements relating to the subject matter of this Licence, whether oral or written.
- 12.2 Alterations to this Licence and to the Schedules to this Licence are only valid if they are recorded in writing and signed by both parties.
- 12.3 This Licence may not be assigned by either party to any other person or organisation, nor may either party sub-contract any of its obligations, except as provided in this Licence in respect of the Agent and the management and operation of the Server and the Publisher's Representative, without the prior written consent of the other party, which consent shall not unreasonably be withheld.
- 12.4 If rights in all or any part of the Licensed Materials are assigned to another publisher, the Publisher shall use its best endeavours to ensure that the terms and conditions of this Licence are maintained.
- 12.5 Any notices to be served on either of the parties by the other shall be sent by prepaid recorded delivery or registered post to the address of the addressee as set out in this Licence or to such other address as notified by either party to the other as its address for service of notices. All such notices shall be deemed to have been received within 14 days of posting.

- 12.6 Neither party's delay or failure to perform any provision of this Licence, as result of circumstances beyond its control (including, without limitation, war, strikes, floods, governmental restrictions, power, telecommunications or Internet failures, or damage to or destruction of any network facilities) shall be deemed to be, or to give rise to, a breach of this Licence.
- 12.7 The invalidity or un-enforceability of any provision of this Licence shall not affect the continuation or enforceability of the remainder of this Licence.
- 12.8 Either party's waiver or failure to require performance by the other of any provision of this Licence will not affect its full right to require such performance at any subsequent time, or be taken or held to be a waiver of the provision itself.
- 12.9 This Licence shall be governed by and construed in accordance with the laws of Scotland.
